



MEMORANDUM OF UNDERSTANDING FOR COOPERATIVE ACTIVITIES

And

**Avertra Corporation**

The Parties

This Memorandum of Understanding (hereinafter referred to as 'MOU') is entered into force on July 25th, 2018 (hereinafter referred to as the 'Effective Date') by and between Al-Zaytoonah University of Jordan (ZUJ), Jordan, and Avertra, Jordan branch, a global integration services, product development and consultancy organization focused on the energy and utilities industry, hereinafter collectively referred to as the "Parties" and individually as "ZUJ" or "first party", and "Avertra" or "second party", depending on the context.

## Article 1

The MOU's objective is to facilitate further cooperation in research and education. This MOU is a statement of intent to foster genuine and mutually beneficial collaboration between the two parties.

# Article 2

This MOU shall remain in force for an initial period of three (3) years from the date of the last signature. Thereafter it shall be automatically renewed for successive three-year periods, unless either of the two parties terminates this MOU by giving six months written notice to the other party. Any amendments to the MOU are subject to approval in writing by both parties.





### Article 3

The second party should seek to promote:

- 1. Introducing Mendix application platform to promote information technology based classroom that will allow students to experience the development process and the quick creation of a simple learning and teaching web application at ZUJ.
- 2. Mobility of undergraduate students
- 3. Mobility of faculty members
- 4. Five vacancies for students summer training for a duration of two to three months from the beginning of the summer course at ZUJ.
- 5. Assisting the students in their graduation projects by providing ideas inspired by industrial problems, to be addressed in the project by the students and faculty members.

#### Article 4

The two parties should seek to promote:

- 1. Joint engineering and IT research activities and publications
- 2. Participation in seminars, workshops, conferences and academic meetings held by the two parties in the fields of product development, energy and utilities industry consultancy.
- 3. Exchange of academic materials and academic publications
- 4. Special short-term academic and training courses
- 5. Advertisement of the second party products, services and activities at ZUJ campus.





#### Article 5

The parties may sign an Intellectual Property Rights (IPR) document in order to secure rights when it comes to research results and publications.

#### Article 6

The second party is not obliged to financially compensate the trainees from the first party and the trainees from ZUJ are not obliged to pay the second party any fees for the training.
